**OTC Derivatives Trade Repository of the HKMA
Revised Technical Specifications for SWIFT WebAccess**

With reference to the circular 2019/219B issued by the Hong Kong Interbank Clearing Limited (“HKICL”) dated 9 July 2019, system enhancement of the OTC derivatives Trade Repository of the HKMA (“HKTR”) will be launched on 17 February 2020 to tie in with the introduction of the new SWIFT WebAccess solution. I am writing to inform that a revised Administration and Interface Development Guide (“AIDG”) is published in response to this enhancement and other AIDG refinements made after 21 April 2017. The new AIDG (version 1.5.3) is attached to this letter and it will start to apply from 17 February 2020.

Institutions which plan to access HKTR via SWIFT WebAccess are reminded to observe the enclosed schedule of major activities and prepared for the simulation test and the connectivity test. The revised Operating Procedures for Hong Kong Trade Repository Reporting Service – User Manual for Participants (“User Manual”) and Simulation Test Package will also be published in due course to facilitate your preparation.
