OTC Derivatives Trade Repository of the HKMA <u>Connectivity Test for SWIFT WebAccess</u>

Further to my letter dated 30 August 2019, regarding the system enhancement of the OTC derivatives Trade Repository of the HKMA ("HKTR") that will be launched on 17 February 2020, institutions which plan to access the HKTR via SWIFT WebAccess (correctly referred to as "Participants" below) are reminded to complete the setup for Simulation Test and Production Implementation by 15 November and 13 December 2019 respectively. To verify the setup, Participants should conduct connectivity tests for Simulation Test from 18 November to 11 December 2019 and for Production Implementation from 16 December 2019 to 24 January 2020. I wish to append below the latest schedule of major activities for Participant's reference:

All Participants are required to complete both connectivity tests. The connectivity test procedures (Attachment 1 and 2) are attached to this letter for Participants' reference. Participants are strongly recommended to complete individual SWIFT's user setup and conduct Connectivity Test for Production with each operating staff of HKTR.

To facilitate communication between HKTR and Participants, we would appreciate it if Participants nominate their contacts for the upcoming testing and implementation activities via email hktr@hkma.gov.hk by 11 October 2019. The nominees should be responsible for coordinating the setup, testing and implementation activities for SWIFT WebAccess solution according to the schedule, among users who are operating HKTR in his/her institution.

Upon completion of the connectivity tests, the nominated co-ordinator should complete and return the attached Test Result Reply Forms to HKTR via email hktr@hkma.gov.hk on or before 13 December 2019 for simulation test environment (Attachment 3) and 30 January 2020 for production implementation (Attachment 4).
