OTC Derivatives Trade Repository of the HKMA Simulation Test for SWIFT WebAccess

Further to my letter dated 2 October 2019, regarding the connectivity test for SWIFT WebAccess migration, Institutions which plan to access the OTC derivatives Trade Repository of the HKMA ("HKTR") via SWIFT WebAccess (correctly referred to as "Participants" below) are reminded to complete the setup, connectivity tests and simulation test according to the enclosed schedule of major activities and follow up actions.

All participants are required to complete the simulation test by 24 January 2020. The Simulation Test Procedure (Attachment 1) is attached to this letter for Participants' reference. Nominated co-ordinators should complete and return the attached Test Result Reply Form (Attachment 2) to HKTR via email hktr@hkma.gov.hk on or before 6 February 2020. Participants are encouraged to complete the connectivity tests and simulation test at the earliest to ensure they are ready for the system changes in login and administrative functions.

A big-bang approach will be adopted for the migration between 15 and 16 February 2020, after which Participants will not be able to access to HKTR's user interface via the existing SWIFTNet Browse channel. Participants who are currently using SWIFTNet Browse as their sole channel for access to the user interface, subject to their assessment and consideration, might set up internet connection as an alternative access channel to safeguard their normal operational use of HKTR.
