This document version incorporates a series of updates made to AIDG version 1.4.1 for Existing 4 Products and 15 New products. Please refer to the Change Log (from AIDG 1.4.1 to 1.4.2) for more information.		To cope with the proposed expanded mandatory reporting requirements made in the consultation paper published on the 30th September 2015 for the OTC derivatives transactions, some technical and data field reporting requirements in the HKTR have been refined accordingly. This document version incorporates a series of updates made to AIDG version 1.4.2 on Existing 4 Products & 15 New products of IRFXEQ, together with all other IRFXEQ products, the new asset classes - Credit (CR) and Commodity (CM) and valuation transaction information reporting. For the change made for the Existing 4 Products & 15 New Products of IRFXEQ, please refer to the Change Log (from AIDG 1.4.2 to 1.5) and Change Log (from AIDG v1.5 to v1.5.1) for more information.		This document version incorporates a series of technical updates and refinements made to AIDG version 1.5.1 in response to the revised regulatory proposals on various technical aspect and mandatory reporting data field requirements in the further consultation paper and gazette published on 15 July 2016. Please refer to the Change Log (from AIDG v1.5.1 to v1.5.2) for the update.		This version incorporates technical updates made to AIDG version 1.5.2 in response to the TR enhancement for accommodating the new SWIFT WebAccess solution introduced by SWIFT on 17 February 2020, together with some refinements on document/wording (textual amendments) since last published. Please refer to the Change Log (from AIDG v1.5.2 to v1.5.3) for the update.		This version incorporates technical updates and refinements made to AIDG 1.6 regarding the industry feedbacks received, also include the updates of the existing coding scheme "FloatingRatesIndex" to align with the latest FpML Coding Schemes version 1.14 published on 27 March 2020 and the update of version of the client software supported by the HKTR system. The key changes made in the revised AIDG include (i) updates of coding schemes supported in the HKTR reporting templates, (ii) remaining of "Trade Identifier" (UTI) to "Unique Transaction Identifier - Unique Swap Identifier (UTUSI)", (iii) cessation of the outdated reporting templates, i.e. the format version - CSV1.0, CSV2.0 and FpML 5.2 and (iv) corresponding changes in some business validation rules. Please note that the regular update has been implemented to the coding scheme "FloatingRatesIndex" supported in the HKTR system on a bi-monthly basis in order to cope with the floating rate indices emerging from the markets from time to time. The details of the latest update of coding scheme "FloatingRatesIndex" will be reflected in the AIDG Appendix F and the coding scheme is available to be downloaded separately in the HKTR Info Page website. Important Notes		Note 1: Please note that the 10th July 2015 Reporting Rules requirements (including mandatory reporting data fields requirements) and TR supported values & enumerations are updated into the AIDG v1.3, AIDG v1.4 and AIDG v1.4.1 are still useable in term of technical aspect, those reporting requirements in these versions are outdated and obsolete. Reporting entities are required to adopt the AIDG v1.4.2 as soon as possible to fulfil the 10 July 2015 Reporting Rules Requirements and to observe the deadlines for the mandatory reporting requirements accordingly.						Note 2: In response to the revised regulatory proposals on various technical aspects and mandatory reporting data field requirements in the Securities and Futures (OTC Derivative Transactions – Reporting and Record Keeping Obligations) (Amendment) Rules 2016 ("Amendment Rules"), the Gazette (Government Notice Number 3912) and the Further Consultation Conclusions on Introducing Mandatory Clearing and Expanding Mandatory Reporting ("Phase 2 Reporting"), a set of update requirements and technical specifications for reporting is set out in the version 1.5.2 of Administration and Interface Development Guide ("AIDG"). Reporting entities are reminded to read the revised AIDG (version 1.5.2) carefully to ensure they are fully aware of the changes from the AIDG (version 1.5.1) published on 6 June 2016. Though the Phase 2 Reporting will not come into effect immediately, the existing reporting standards and technical specifications found in all the previous versions of AIDG will be no longer able to support the mandatory reporting requirements under the Phase 2 Reporting which will be commenced on 1 July 2017. Reporting entities are reminded to make preparations to adopt the revised AIDG (version 1.5.2) as soon as possible to ensure that they will be ready when the Phase 2 mandatory reporting requirements start to apply.												Note 3: As the outdated reporting templates (i.e. the format version - CSV1.0, CSV2.0 and FpML 5.2) published in the previous AIDG versions will be no longer supported by the HKTR system, the corresponding trade submission will be rejected by the HKTR system once the AIDG 1.8 is effective.
